BUSINESS OF THE MONTH

PURPOSE

The Carroll County Chamber of Commerce recognizes one local business as “Business of the Month” for outstanding achievement and/or exceptional customer service during the second week of each month.

NOMINATION PROCESS

A nomination and selection process conducted by the Business Development Council of the Carroll County Chamber of Commerce determines the Business of the Month Award winner. Any member of the community, business, or organization in Carroll County may nominate businesses. All nominations should be submitted to the Business Development Council utilizing the official nomination form. The official nomination form is on the Carroll County Chamber of Commerce website, may be picked up at the Chamber office, or emailed upon request by staff from our office. Nominations will remain on file and remain under consideration for up to twelve months from the date of submission.

ELIGIBILITY CRITERIA

- Current member, in good standing, with the Carroll County Chamber of Commerce.
- In business for at least two (2) years.
- Locally operated franchises are eligible
- Should meet at least one (1) of the following criteria:
 - Have demonstrated outstanding support of the community
 - Provide exceptional customer service and/or superior products
 - Respected as being an ambassador of goodwill for our community

BUSINESS OF THE MONTH

- Receive a certificate of recognition with the business name, month, and year of presentation
- Business of the Month sign to place outside of the business for that month
- Announcement on the Chamber’s social media pages, the Chamber’s monthly newsletter, and local print media outlets. We cannot guarantee articles sent to the local media will run or determine a run date; articles will run when/if space allows.

SELECTION PROCESS

Deadline for nominations for consideration for the next cycle is the **second (2nd) Monday** of each month. However, nominations will remain on file and remain under consideration for up to twelve months from the date of submission. Chamber staff will verify the nominations to ensure they meet eligibility criteria. The Business Development Council will be responsible for final review and selection.
